

RESOLUTION: NOTICE OF PUBLIC AUCTION

7. This resolution shall be published in the Daily Record for two consecutive weeks with the final publication at least seven (7) days prior to the date of the auction.
8. A bank check, money order or cash for the total bid is payable at the time of the auction.
9. All items will be sold in an "as is" condition and all sales are final.
10. For the vehicles listed by the Wharton Police Department all Towing and Storage Fees must be paid in full prior to purchase of items listed on the attached schedule.
