FORECLOSED/VACANT AND/OR ABANDONED PROPERTY REGISTRATION

INSTRUCTIONS:

- 1) Any property which is in foreclosure, vacant and/or abandoned shall within 10 days register said property with the Borough as per municipal ordinance 231 Article V.
- 2) Please complete the form below and submit to the Zoning/Housing department with the appropriate fee.

FEE:

The initial registration fee of 500.00 is due within 10 days of property becoming foreclosed, vacant and, or abandoned. Each subsequent fee shall be due on January 1st of each subsequent year that the property remains foreclosed, vacant and, or abandoned. If the Zoning/Housing officer determines that the foreclosed/vacant property also has property maintenance violations an additional annual fee of \$2,000.00 can be charged until as such time that the property comes into compliance with property maintenance requirements.
